

# Father's Day 2019 Competition

## Terms and Conditions including the Privacy Statement

### Terms and Conditions

1. The Promoter is Lend Lease a division of Lend Lease Property Management (Australia) Pty Limited ABN 61 002 894 153 of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is (02) 6583 7377. NSW Permit No. LTPS/19/36679.
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the Competition.
3. The following person(s) are ineligible to enter the Competition:
  - (a) employees of:
    - (i) the Promoter; and
    - (ii) the Promoter's related bodies corporate (as that expression is defined in the *Corporations Act 2001* (Cth), and associated agencies, companies and contractors; or
  - (b) members of the Immediate Families of the employees referred to at paragraph 3(a).
